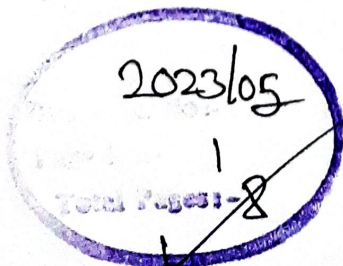

## TRUST DEED

This DEED OF TRUST is executed at Chennai this the 9<sup>th</sup> day of June 2005, by **Mr.K.K.RADHA KRISHNAN**, son of K.P.Kaliaperumal, Hindu, aged about 43 years, residing at 26, Avvai Nagar, Padi, Mugappair, Chennai-50, hereinafter called the "**FOUNDER**" (which expression shall also include wherever the context admits himself, his successors, heirs, legal representatives, executors, administrators and assigns) witnesseth as follows:-

Whereas the **FOUNDER** is desirous of creating an EDUCATIONAL TRUST by setting apart and establishing a fund for the benefit of the society to improve better educational facilities and for other objects and purposes hereinafter expressed.

WHEREAS the TRUSTEE hereinafter mentioned has at the request of the SETTLOR agreed to act as TRUSTEE of these presents upon the terms and provisions hereinafter contained.

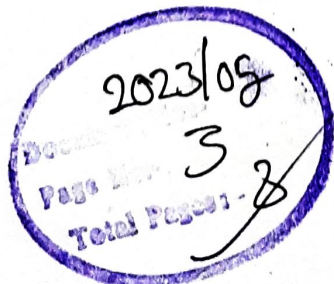

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS

1. In order to effectuate the said objects of creating a TRUST, the SETTLOR has delivered to and made over to the TRUST a sum of Rs.1000/- (Rupees One Thousand only) to have and hold the same and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter called "the TRUST FUND") for the educational objects and purposes and uses hereinafter expressed with the powers on the terms and conditions herein contained of and concerning the same.
2. The name of the Trust shall be **RAAJAMMAL EDUCATIONAL TRUST**, and the Registered Office of the Trust shall be situated at 7272, 8<sup>th</sup> Main Road, Rajammal Street, TNHB Scheme, Ayappakkam, Chennai-77, which may be shifted from time to time to such other place or places, as trustees may deem fit and proper at their discretion.

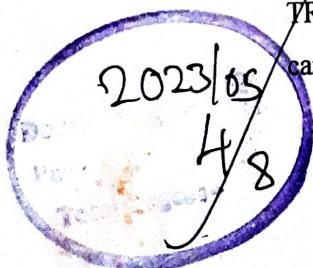

3. THE OBJECTS OF TRUST shall be:

- i) To establish, promote, set-up, run, maintain, takeover, assist, finance support in setting up and/or maintaining and/or running schools, other educational institutions for the benefit of the poor and deserving people.
- ii) To establish, maintain and run libraries, hostels, Reading rooms, Dormitories, Recreation Center and all other facilities as are calculated to be of use in imparting education to the public and proper running of the Educational Institutions.
- iii) To undertake and promote fundamental and educational research work in all subjects, including publications for the purpose thereof.
- iv) To give scholarships, prizes, school and college fees, books and to gift stationery and other articles necessary to the poor and deserving students for the proper execution of their studies.
- v) To procure gifts, medicines, clothing, equipments and food stuffs and apply for grants and aids in cash or in kind from various agencies and government departments.
- vi) To award grants, scholarships, fellowships and similar financial assistance or encouragement for the advancement of research in educational field.
- vii) To give, provide and /or render help and assistance in cash or kind to the poor and/or destitute people, widows, etc.
- viii) To give, provide and /or render help and assistance to and/or implement any scheme for providing livelihood and upliftment of the poor.
- ix) To conduct fund raising programmes to augment funds for the above purpose.
- x) To do all such other lawful acts as may be necessary or incidental and conducive to the attainment of the above objects or any one of them.
- xi) The trust shall be open to all, irrespective of caste, creed, community or religion and sex.
- xii) The above objects are independent of each other and the TRUSTEES may from time to time, apply the funds of the trust in carrying out all or any of the objects of the trust.

5. The ~~FOUNDER~~ Mr.K.K.Radha Krishnan, shall hold the office of MANAGING TRUSTEE for his lifetime and he shall manage the affairs and business of the trust. After his lifetime, the elder member of his surviving legal heirs shall succeed the office of the MANAGING TRUSTEE.

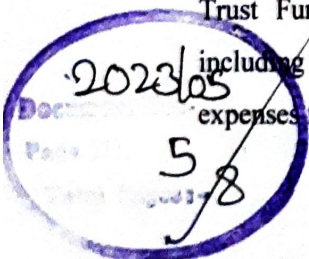
6. All the trustees or their successors-in-office shall have full power and authority to administer the Trust, its properties and affairs and to do all acts, deeds and things that are calculated to fulfill the objective of the Trust for which the trust is established.

7. The MANAGING TRUSTEE shall maintain true and correct accounts of the Trust and a correct record of their deliberations and shall have the accounts duly audited by a qualified Chartered Accountant.

8. The MANAGING TRUSTEE shall have the power to appoint personnel and Staff for running the various institutions that may be organised and started by the Trust from time to time.

9. The MANAGING TRUSTEE shall amend and rescind rules and regulations of the Management and administration of the trust in consultation with other TRUSTEES.

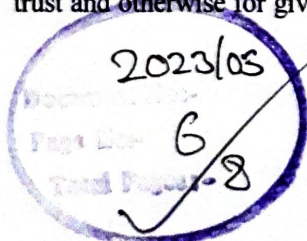
10. The MANAGING TRUSTEE shall collect and recover the income of the Trust Fund and shall provide for all costs, charges and incidental expenses including insurance premium, expenses of ordinary repairs, all the outgoings and expenses for the management and administration of the trust.

11. The TRUSTEES shall after providing for the above mentioned payments and disbursements, apply and utilize the net income or the corpus of the Trust funds for the benefit of the citizens of India without any discrimination on the ground of religion, sect, caste or creed or accumulate after complying with the provisions of the Income Tax Act 1961.
12. In addition to the returns from the securities, the TRUSTEES shall also accept donations from the general public or by TRUSTEES themselves.
13. No TRUSTEE is competent to collect donation or spend any of the trust amount for any purpose individually without the concurrence of the Trust by way of resolution.
14. No amount or fund of the Trust shall be spent by any of the TRUSTEES directly without crediting the same into the Bank's account of the Trust. The MANAGING TRUSTEE or TRUSTEES shall open and operate the Bank Accounts in the name of trust or its institutions jointly or separately.
15. All the books and registers relating to the Trust shall be kept at the Registered Office of the Trust only and they shall be open to inspection by the Trustees jointly or individually.
16. The TRUSTEES shall constitute committee either among themselves or from general public for the purpose of regulating or carrying on various affairs relating to the conduct of the Trust.
17. The TRUSTEE shall be deemed to have retired from the TRUST by reason of his/her having been declared as insolvent by any Court of Law or by reason of mental derangement or involvement in criminal offences or moral turpitude.
18. The power to appoint new or additional trustees shall vest on the MANAGING TRUSTEE.
19. The TRUSTEES shall be entitled to sue or be sued in the name of Trust.
20. The TRUSTEES shall be at liberty to retire or resign at any time without assigning any reason but on giving one-month notice of his/her intention to do so.
21. All the TRUSTEES unless they voluntarily resign or otherwise decide, shall continue to be the Trustees during the term of their natural lives.
22. The TRUSTEES may from time to time form schemes and rules and regulations to carry out the objects of the trust and for managing the affairs of the trust and otherwise for giving effect to the object and purposes of the trust and vary

the same from time to time as the trustees may in their discretion deem fit and proper.

23. The TRUSTEES shall have the power and their uncontrolled discretion, instead of acting personally, to employ and pay agent to transact any business or to do any act whatsoever in relation to the Trust of these presents.

24. The TRUSTEES shall have full power to compromise or compound all actions, suits, and other proceedings and settle differences and disputes touching the Trust Estate and/or the Trust properties and to refer any such differences of disputes to arbitration and to adjust and to settle all accounts relating to the Trust Estate and/or the Trust properties and to do all other acts and things fully effectually without being liable or answerable for any bonafide loss occasioned thereby.

25. The TRUSTEES shall not be entitled to any remuneration for the discharge of his/her function as a TRUSTEE. In case the TRUSTEE is called upon to discharge any function other than that of a TRUSTEE he/she shall be paid such remuneration as may be decided by the Board of Trust from time to time.

26. Without prejudice to the generality of their powers, the MANAGING TRUSTEE shall have the power to borrow money for the purpose of the Trust from individuals, Corporate Bodies, Bank and/or other Financial Institutions.

27. The TRUSTEES shall at all times stand indemnified in respect of anything they may have done in respect of any matter relating to this Trust.

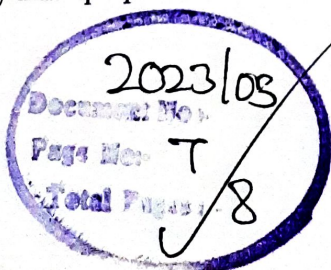
28. The TRUSTEES shall have the power to do and perform all things required necessary to be done or performed for the purpose of managing the Trust.

29. The TRUSTEES shall meet as often as may be necessary or convenient to transact business and they may take decisions also by circulation or resolutions.

30. The Financial year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of every year.

31. On dissolution or winding up of the Trust, the funds of the Trust shall be transferred to Trusts or societies or Institutions having similar objects.

32. The TRUSTEES may demise the immovable property or properties for the time being and from time to time belonging to the trust either from year to year for any fixed term or for any terms of years or on monthly tenancies at such rent and subject to such covenants and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.

33. On dissolution or winding up of the Trust, the funds of the Trust shall be transferred to Trusts or societies or Institutions having similar objects recognized by the Income Tax Authorities.

34. The funds of the Trust shall be utilized only towards the objects and no portion of it would be distributed in any manner to the Trustees or persons defined in sec.13 (1)(c) of the Income Tax Act, 1961.

35. Not more than 5% of the income of the trust shall be applied for any religious purposes or given to religious institutions.

36. Alienation of immovable property, if any, shall be done with the due and prior approval of the Income Tax Department.

37. It shall be lawful for the trustees to take over the management of any other trust affairs and its properties and to carry out the objects of the trust amalgamated with this trust and also to promote or carry on the affiliation or amalgamation of such other trust and its institutions.

38. It is expressly declared that no part of the Trust property or its income or Trust fund shall be supplied for any purpose outside India or for any purpose, which is not a public charitable accordingly.

39. The Trust has no immovable property at present.
